About the Event

Making this our fourth charity golf event, the HAGAR Charity Golf Tournament 2018 is gearing up to present a most delightful and enjoyable game for players of all skill levels, with the System 36 Stableford format for the 18-hole challenge.

Established in 1994 and today, operating in 10 countries worldwide, HAGAR is a registered charity in Singapore and part of a global humanitarian organisation that is committed to the recovery and economic empowerment of women and children who have survived extreme human rights abuse, particularly **human trafficking, gender-based violence and sexual exploitation.**

At HAGAR, we walk the whole journey of recovery with each individual, providing holistic healing, legal protection, safe accommodation, education, economic empowerment and reintegration to their original homes or communities. We embrace some of the most complex cases in the world, stay focused on the individual and do whatever it takes to restore a broken life.

A global crime, human trafficking activities happen in every country and Singapore is not spared either. HAGAR Singapore has been working closely with the Singapore Government through its Inter-Agency Taskforce on Trafficking in Persons to tackle trafficking issues and to raise awareness on the matter. Since 2015, HAGAR Singapore has been helping women and girls who have been trafficked into Singapore. Upon their rescue, we help rebuild their confidence and self-worth and reduce their vulnerability to re-exploitation by providing education and vocational training opportunities. Through the trauma recovery programme, we have seen more than 150 survivors and have safely reintegrated women from Bangladesh, China, India, Indonesia, Myanmar, the Philippines, Sri Lanka and Vietnam back to their home countries.

With your support in the Tournament this year, we hope to raise \$150,000 to support vulnerable women and child survivors of trafficking and abuse.

Besides a great game of golf with exciting contests and prizes, and a sumptuous banquet, you can be sure that on top of all the fun, your pitch will empower the future of these survivors and give them a reason to live on, and be strong.
