## ABOUT THE EVENT

In commemoration of 25 years of working with some of the most exploited and vulnerable communities in society, the Hagar Charity Golf Tournament 2019 is set to present an energising and memorable golfing experience for players of all skill levels.

Held at the best-in-class Island Course at the Singapore Island Country Club this year, go for the sweet spot by enjoying a great game of golf amidst fun-filled on-course challenges and warm hospitality, whilst doing good for a meaningful social cause at the same time. The game will be played in the System 36 Stableford format for the 18-hole challenge.

Founded in 1994 and operating from 9 countries worldwide, HAGAR is a registered charity in Singapore and part of an international organisation that is committed to the recovery and economic empowerment of women and children who have survived extreme human rights abuse, particularly human trafficking, gender-based violence and sexual exploitation.

Partnering with the Singapore Government, Hagar combats issues of human trafficking and exploitation among migrant workers by providing victim care to trafficked survivors and exploited foreign domestic workers, and raising awareness among the local community.

The end result of the years of dedicated recovery care and empowerment support through literacy and skills training, is the transformation of lives – women and children with renewed dignity and confidence, who are living productive lives and empowered to become leaders of change. Many of Hagar's former beneficiaries are now medical doctors, engineers, lawyers, counsellors, social workers; passionate men and women who are contributing back to their own communities.

So make your mark in the fight against human trafficking and exploitation in this celebratory occasion and swing to rebuild the lives of survivors, helping them to take that next shot in life. **We hope to raise \$200,000 through the Tournament this year, we can only do this with your support.**
